

## **Indian Nuclear Policy**

#### Harsh V. Pant & Yogesh Joshi

This short introduction provides a clear and succinct account of the evolution of Indian nuclear policy over seven decades since Independence. Situating India's nuclear behaviour in its quest for global status, demands of national security, vagaries of domestic politics, and the idiosyncrasies of the individuals who led its nuclear programme, it explains how India's engagement with the atom is unique in international nuclear history and politics.

The five chapters follow a linear historical narrative explaining how India's nuclear pioneers established the nuclear programme after independence; India's development of a 'nuclear weapons option after the Chinese nuclear test of 1964; its nuclear refrain after the 1974 PNE; its pathways to nuclearisation in the decade of 1980s and 1990s; and finally its rise as a nuclear weapons power after the 1998 nuclear test.

## **The Partition of India**

This short introduction provides a comprehensive account of the causes, experience, and aftermath of the Partition of India and its legacies in the South Asian subcontinent. The author highlights three aspects of the Partition: it was not a predestined 'clash of civilizations' between Hindus and Muslims; it was a long-drawn-out process spanning beyond a decade rather than being confined to the year 1947; and third, there is no single template to understand the experiences of dislocation, rehabilitation, migration, and violence in Bengal and Punjab. The book brings together the contextual histories of causality, of violence and loss, and of nation-making and introduces its readers to major scholarly debates in a brief but succinct manner.






